SHORT BIOGRAPHY

Jeffrey Rosen is a professor of law at George Washington University. He is also the president and CEO of the National Constitution Center in Philadelphia, the only institution in America chartered by Congress "to disseminate information about the U.S. Constitution on a non-partisan basis. In addition, he is a contributing editor at The Atlantic. He was previously the Legal Affairs Editor of *The New Republic* and a staff writer for *The New Yorker*. His latest book is *William Howard Taft*. His other books include *Louis D. Brandeis: American Prophet, The Supreme Court: The Most Democratic Branch, The Naked Crowd*, and *The Unwanted Gaze*, which The New York Times called "the definitive text in privacy perils in the digital age." He is co-editor of *Constitution 3.0: Freedom and Technological Change*. Rosen is a graduate of Harvard College, summa cum laude; Oxford University, where he was a Marshall Scholar; and Yale Law School. After law school, he clerked for Chief Judge Abner Mikva on the U.S. Court of Appeals for the D.C. Circuit. His essays and commentaries have appeared in the New York Times Magazine, The Atlantic Monthly, on National Public Radio, and in The New Yorker, where he has been a staff writer. A reviewer for the L.A. Times called him "the nation's most widely read and influential legal commentator."
