Economic effects of public restraints

- The main sources of distortions of competition (or market failure) derived from restrictive public procurement rules and practices are 'quasi' monopsonistic and result in:
 - Waterbed effects
 - Pro-collusive features
 - More intense effects in case of centralisation or aggregation of demand



"To help students find their meaningful path in the law, two years ago I worked with Professor Todd Peterson to develop an evolving online resource where our professors could share their wealth of knowledge about different practice areas with our students-and where our students could have a resource for delving into different practice areas, reaching out to helpful mentors, and exploring different career paths. This guide has become an invaluable resource for our students, thanks to the generous contributions of our colleagues."

"In my national security law class, I have developed a wide variety of 'asynchronous' activities that the students can participate in. The students love having these alternative modalities for learning the material, and they give me another great way to evaluate students beyond exam grades (and to provide recommendations to employers)."


