Then read the case again, paying close attention to the language the court uses and being sure to look up any unfamiliar terms. Next, read the note material accompanying the case and carefully consider the issues and questions the notes raise. Then read the case a third time. During this third reading, consider how the case informs your study of the note material following the case. After the third reading, prepare a brief of the case. Then read the case a fourth time and revise your brief if needed. Review the note material again, jotting down answers to the questions raised.

Reading each case four times will be necessary to fully prepare for class.

Do not come to class unprepared.

You are required to brief each case.
