Hammontree v. Jenner is a demanding case, so read with care. Most of you will find that reading for law school is quite different from the kind of reading you required your undergraduate education. It will take time to learn and develop these skills. Please be patient with yourselves as you embark on the journey of learning to read and think like a lawyer. You will be amazed by how much you absorb and learn in the few first few months of law school – the learning curve is steep.
